- Carol was pleasantly surprised to see how high circulation for the library's materials was during the pandemic. Believes this shows how important the library is to the community.
- Kewaunee was the recipient of several CARES Act grants throughout the pandemic.
- Kewaunee also received a \$3000 grant from the ALA for the Libraries
   Transforming Communities program. The library was trained as a community
   facilitator and held a community conversation with members of the Latino
   population in Kewaunee to discuss what specific needs the library could help fill.
   The grant funding will also allow the library to add additional materials to their
   Spanish-language collection.

 The Grant Committee will meet in July to review the next round of NFLSsponsored grants.

#### 8.5 Personnel Committee - Ken Harter

- Personnel Committee met in May and approved the Director's Review Policy & Procedures.
- The Committee is in the process of collecting performance surveys from the member library directors and will also send out surveys to the Board members and NFLS staff.
- The Committee will meet in August to review the survey results, set Director Goals for next year, and approve any recommendations for salary adjustments for the director and staff.

#### 8.6 Director's Report - Tracy Vreeke

- About half of all Wisconsin libraries are fully open without restrictions. About a
  quarter are open with continued capacity requirements and a quarter remain
  closed. Most of NFLS member libraries are open without restrictions.
- Member libraries are now beginning their Summer Reading Programs and have planned mostly virtual programming but will also provide in-person programs as much as they are able to do so.
