# Why?

#### Assists with:

- Trustee Competency Knowing the role of the Trustee and director, the system's mission, current library issues, and state and national laws governing libraries.
- Board operations Familiarity with the agenda and order of business, making motions, voting, minutes approval, and state Open Meeting Act requirements for the board.
- Strategic planning Working with the director to develop a long range plan for the system.
- Succession planning A conscious Board will plan that provides guidance on identifying and sourcing potential Trustees who can fulfill key requirements. This helps appoint new trustees quickly in a structured manner, and the Board business can continue without disruption.
- Board Evaluations Self-evaluations can help the Board identify areas which need to further development or education.
