## 5.1 President – Julia Wallace

# 5.2 Treasurer's Report – Kathy Pletcher

- Year-end balance is \$74,302 mainly from interest income and salary savings from vacant position.
- What can be done with year-end funds:
  - Reserve Fund can allocate to get to the 10-15% goal set by the board
  - \$2000 for purchases needed for new employee
  - Keynote speaker \$3000
  - I&I Grant remaining balance

Member Campbell made a motion to allocate the year-end surplus of \$23,833.40 to bring the reserve fund to 12%, allocate \$2000 for equipment for new employee, sponsor the WLA Keynote speaker, and allocate the remaining balance to the NFLS Innovation & Improvement Grant fund. Member Lefebvre seconded. **Motion carried.** 

## 5.3 Finance Committee – Kathy Pletcher

 Set up grants review committee so grant applications are not just reviewed by the Finance Committee.

Member Rosik made a motion to accept the Finance Committee report. Member Fernandez seconded the motion. **Motion carried.** 

## 5.4 LD&L Update - Pletcher & Campbell

- Library Legislative Days board members and library directors attended to meet with legislators to thank them for budget allocations and to request more allocations if possible.
- Next year would like to put together short clips to share with legislators of patrons speaking to how the library impacts their lives.

#### 5.5 Personnel Committee – Ken Harter

- January meeting will set the agenda and review committee member responsibilities and duties.
- At the May meeting, the committee will plan and review the director's position, including collecting surveys of staff and trustees regarding the director's performance.
- At the September meeting, the committee will conduct director review and make recommendations regarding salary adjustments for director and staff.

## 5.6 Director's Report – Tracy Vreeke

- Remote Employee Agreement draft to be reviewed at May Personnel Committee meeting.
- WLA (GB) & WAPL are both in area and board members can attend if they are interested
- Tracy will share trainings, if available, for Compassionate Accountability and Ryan Dowd's Homelessness Training presentations which provide training for librarians in regard to dealing with challenging situations and patrons.
