Vreeke said with the ILS merger talks she feels this conversation has started, which is one reason member libraries voted to have the OWLS agreement in place. The

Committee wants to have a meeting with OWLS prior to signing the agreement. Vreeke said at the last Board meeting they decided that the NFLS Executive Committee would be the ones to meet with OWLS. Campbell also wants to invite Maxwell to this meeting. Vreeke will talk to Bradley Shipps, the OWLS director, to set up a meeting.

• The Committee asked that Vreeke revise and resend her six month goals to the Committee. **Motion carried.**

11. Other business.
